Equipment: All racers need to bring paddleboard, kayak or canoe, paddle and PFD Type III (required). Single Blade paddles for SUPs.

Awards: Special Awards for Overall male and female winners in following age classes: Under 16, 17-25, 26-39, 40-60, 60 and over; both for SUPs, Kayak & Canoe division
